AMENDMENT TO DECLARATION OF RIVERSIDE ASSOCIATES PROTECTIVE COVENANTS

ARTICLE VIII DESIGNATED PARKING

This Article specifies the designated parking area (Designated Parking Area) for Units 3 and 9.

Unit 3, as noted as such on the Plat of Riverside at Carrabelle, shall have the common property adjacent to Unit 1 and adjacent to U.S. Highway No. 98 ~ State Road No. 30 as its Designated Parking Area as shown on Exhibit A attached. Owners of other Units shall not park vehicles or other personal property within this Designated Parking Area without agreement from the Owner(s) of Unit 3.

Unit 9, as noted as such on the Plat of Riverside at Carrabelle, shall have the common property adjacent to Unit 12 and adjacent to U.S. Highway No. 98 ~ State Road No. 30 as its Designated Parking Area for such Unit as shown on Exhibit A attached. Owners of other Units shall not park vehicles or other personal property within this Designated Parking Area without agreement from the Owner(s) of Unit 9.


